The Sarasota International Cricket Club was founded in 1983. It is considered by many to have the finest cricket facility in the southeast U.S. The club's aims are to provide a congenial atmosphere for playing cricket and to promote cricket in Sarasota and beyond.

Candidate playing members are welcome regardless of playing ability, when proposed and seconded by two members who have been members for at least six months and provided the total membership does not exceed the number that allows every member a reasonable opportunity to play.

A candidate playing member's application will be considered for full membership by the club's Membership Committee after three months. Approval depends on the candidate's demonstrated acceptance of the obligations of membership that include good moral character, good sportsmanship and sharing in the off-field work of the club such as ground and buildings maintenance, match catering and fund raising. In the event that a candidate does not become a full member the annual membership fee shall be refunded.

SICC players wear cricket whites including SICC club shirts, or (when playing with a white or pink ball) the SICC colored uniform, and club caps. SICC shirts, uniforms and caps are available from the club captain.

Sarasota International Cricket Club Code of Conduct

As a condition of candidacy or membership, all candidates and members agree that their candidacy or membership may be revoked or suspended by a majority vote of the club's Executive Committee should they be found to have conducted themselves in a way that could bring the game of cricket or the Sarasota International Cricket Club into disrepute. Such conduct includes but is not limited to:

1. Failure at any time to accept the umpire's decision or to show dissent at the umpire's decision.
2. Failure to show respect for opponents, your own captain and team, the role of the umpires and the game's traditional values.
3. Use of verbal abuse, assault, intimidation or threats to any umpire, player or spectator.
4. Use of any conduct or language towards any umpire, player or spectator in a manner which offends, intimidates, disparages, or vilifies the other person based on that person's race, religion, color, descent or national or ethnic origin.
5. Use of crude or abusive language or offensive gestures.
6. Cheating or sharp practice such as appealing knowing the batsman is not out, advancing on the umpire in an aggressive manner when appealing, seeking to distract an opponent with persistent clapping or unnecessary noise under the guise of enthusiasm and motivation of one's own side.

SICC Member Pledge

1. to conduct himself or herself in accordance with the club's *Code of Conduct*
2. to wear only proper SICC club attire when playing
3. to contribute a minimum of four hours of work every calendar quarter as designated by the club
4. when scheduled to play, to arrive at the ground for a Team Meeting 45 minutes before start of play and to remain 60 minutes after the finish of play and while at the ground to promptly, fully and courteously carry out those tasks given to him or her by the Match Manager
5. to refrain from consuming alcoholic beverages until after the close of play and then only in strict moderation
6. to communicate only in English when on SICC property.

Complaints of conduct contrary to the Code of Conduct and Member Pledge shall be made to the Executive Committee. A decision by the Executive Committee to revoke or suspend candidacy or membership or to suspend playing privileges based on a finding of conduct contrary to the code shall be binding on all candidates and members.
